

HOUSE RULES

TO: OUR MEMBERS

These rules are established for the singular purpose of setting a standard of conduct within the Lounge to the end that EVERY member will get the utmost benefit from their association with OUR Branch.

The Executive committee is confident that ALL of our MEMBERS and GUESTS will observe these rules. To do so will ensure that we all uphold the good name and traditions of the Royal Canadian Legion in general and OUR BRANCH in particular.

HOURS RULES:

1. All Members and Guests are advised that while they are on the premises or property, no behaviour will be tolerated which interferes in any way with the use and/or enjoyment of our facilities by their fellow members and/or guests. Unnecessary noise, foul language or excessively loud conversation of any description WILL NOT BE TOLERATED.
2. The stewards/bartenders have complete authority in the Lounge and all members will be guided by their instructions. No member shall reprimand, nor interfere with, the stewards/bartenders or any staff members. Any complaints with respect to service or employee's behaviour must be made in WRITING to the Branch Executive.
3. Members are expected to respect the furniture, furnishings and all other equipment in their Lounge and any members who is found to have caused any willful damage to same or, by their actions caused any expense to the Lounge through negligence or improper conduct, may have their Lounge privileges revoked in accordance with the General By-Laws and in addition, will be required to reimburse the Branch forthwith for any expenses or costs incurred resultant of act or actions.
4. Table hopping (uninvited/unwelcome visiting), begging, soliciting or selling tickets (except wherein the case of the sale for a legitimate Branch project or function) is strictly forbidden.
5. Any member asked to leave the premises by the steward/bartender on duty will do so IMMEDIATELY or face possible deprivation of Lounge privileges.
6. Members are responsible for the conduct of their guests. No member shall bring into OUR Lounge any guest of ill repute or undesirable character. ALL GUESTS MUST 'SIGN IN'.
7. Lounge dress for ALL MEMBERS AND GUESTS should be such as not to make other patrons uncomfortable. Where, in the opinion of the steward/bartender on duty, a person's dress in

inappropriate, that person (member or guest) shall be refused service and requested to vacate the premise immediately.

8. Gaming, other than authorized by the Branch, is not permitted.
9. No member or guest shall solicit support from other members or guests which is intended to be counter supportive for an activity which is, or has been authorized by an established committee for the enjoyment or benefit of our Branch and Members. The appropriate place for any such action is during the course of a duly constituted meeting.
10. Any member whose conduct is disorderly or is found to be breaking any of these posted rules, shall be required to leave the premises immediately and may be deprived of their Lounge privileges for a period to be determined by the Complaints Committee, in accordance with Article Three of the General By-Laws. It is the duty of the steward/bartender to have the person(s) removed if necessary.
11. Alcohol IS NOT permitted in any of the washrooms.
12. Except for medical and religious purposes, **no head coverings will be permitted to be worn** within BC Yukon South Similkameen Branch 192 of the Royal Canadian Legion. Proof of medical and/or religious pursuits may be required to be exempt from this rule. This rule does not extend to the Hall when rented. The policy will be reviewed annually by the Executive Committee and brought before the General Membership for revision as required. **This rule to be in effect without change for one year March 2017 to March 2018.**
13. No outside food to be brought into the canteen for consumption unless it's for everyone. Bartenders meals are excluded.
